### Report on Audit of Financial Statements

#### Opinion

We have audited the accompanying financial statement of Vardhman Airport Solutions Private Limited ("the Company") which comprises the Balance Sheet as on March 31, 2024, and the Statement of Profit and Loss for the period then ended & notes to the financial statements including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 in the manner so required and give a true and fair view in conformity with the Indian Accounting Principles generally accepted in India, of the financial position of the company as at March 31, 2024, and the profit for the year ended on that date.

#### Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAS) specified under section 143(10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Other Information

The Company's Board of Directors is responsible for the other information. The other information comprises the information included in the Management Discussion & Analysis, Board's Report including annexures to Board's report, Business responsibility report, but does not include the financial statements and our auditor's report thereon.



Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information identified above when it becomes available and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other Information; we are required to report that fact. We have nothing to report in this regard.

This responsibility includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal control, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

**1. Corporate Information**

M/s VARDHMAN AIRPORT SOLUTIONS PRIVATE LIMITED is a private limited company domiciled in India and incorporated under Companies Act, 2013. The company is engaged in Manufacturing and supply of Airport LED lights. Vardhman Airport Solutions Pvt Ltd provides quality product, solution and services for Airfield Lighting system, Visual docking guidance system, Photometric equipment, ELV & Security Systems for commercial & defense airports. The company also provides design inputs and engineering solutions as value-add services to clients.

**2. Significant Accounting Policies**

The financial statements have been prepared in accordance with applicable Accounting Standards as prescribed under Section 133 of the Companies Act, 2013 ('the Act') read with Rule 7 of the Companies (Accounts) Rules, 2014 Significant accounting policies applied in preparing and presenting these financial statements are set out below. The financial statements are presented in Indian rupees rounded off to the nearest rupee in lakhs, unless otherwise mentioned.

**2.1. Basis of accounting**

The financial statements have been prepared under the historical cost convention in accordance with generally accepted accounting principles and the provisions of the Companies Act, 2013 as adopted consistently by the Company on accrual basis.

**2.2. Revenue Recognition**

a. Revenue from sale of goods is recognized when all significant risks and rewards of ownership have been transferred to the buyer and the seller retains no effective control of the goods transferred and no significant uncertainty exists regarding the amount of the consideration that will be derived from the sale of goods.

Revenue from rendering of services is recognized under the proportionate completion method and no significant uncertainty exists regarding the amount of the consideration that will be derived from rendering the service.

b. Other income are accounted for on accrual basis except where receipt of income is uncertain.

**2.3. Property, plant & equipment and intangible assets**

Property, plant & equipment are stated at cost of acquisition or construction less accumulated depreciation. Cost includes any borrowing costs directly attributable to the acquisition / construction of Property, plant & equipment that necessary.

Intangible assets arising from development are recognised only if there is technical feasibility of completing the intangible asset so that it will be available for use, there is intention to complete the intangible asset, there are probable future economic benefits, resources are available to complete the development and expenditure attributable to the development of intangible asset can be measured reliably.

Depreciation on property, plant and equipment is calculated using the written-down value method (WDV) to allocate their cost, net of their residual values, over their estimated useful lives, as per the useful life prescribed in Schedule II to the Companies Act, 2013. Amortisation of intangible assets is allocated over the useful life of the asset which will not exceed ten years from the date when the asset is available for use.

**2.4. Inventories**

Stock has been valued at the lower of cost and net realizable value. Cost of inventories is ascertained on FIFO basis.

**2.5. Foreign Exchange Transactions**

Transactions in foreign currency are recorded at the exchange rates prevailing at the dates of the respective transactions. In the case of foreign currency denominated monetary assets and in case of monetary liabilities, due to import of material, the loss or gain arising from restatement at the balance sheet date / settlement is charged or credited to the profit & loss account. In case of liabilities incurred for the acquisition or construction of fixed assets, the loss or gain on restatement of liabilities (at the rates prevailing at the year end) or on settlement is included in the carrying amount of the related fixed assets.

**2.6. Taxation**

Tax on current income is provided on the basis of tax laws and tax rates as prescribed by Income-tax Act, 1961. Deferred tax assets and liabilities arising due to timing differences between taxable income and accounting income are computed using the tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date. Deferred tax assets are recognized and carried forward only to the extent that there is a reasonable certainty of their realization.

**2.7. Provisions/Contingencies**

A provision is recognized for a present obligation as a result of past events, if it is probable that an outflow of resources will be required to settle the obligation and in respect of which a reliable estimate can be made. Provisions are determined based on best estimate of the amount required to settle the obligation at the balance sheet date. Contingent liabilities, if any, are not recognized but are disclosed in the Notes to Accounts. Contingent assets are neither recognized nor disclosed in the financial statements.

**2.8. Taxes on Income**

Tax on current income is provided on the basis of tax laws and tax rates as prescribed by Income-tax Act, 1961. Deferred tax assets and liabilities arising due to timing differences between taxable income and accounting income are computed using the tax rates and tax laws that have been enacted or substantively enacted by the balance sheet date. Deferred tax assets are recognized and carried forward only to the extent that there is a reasonable certainty of their realization.

**2.9. Borrowing costs**

Borrowing cost includes interest, amortisation of ancillary costs incurred in connection with the arrangement of borrowings and exchange differences arising from foreign currency borrowings to the extent they are regarded as an adjustment to the interest cost.

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the respective asset. All other borrowing costs are expensed in the period they occur.

2.10 Accounting policies not specifically referred to are consistent with generally accepted accounting principles.
