GDP to grow at 7.4% in FY26: NSO's 1st Advance Estimate

India's real gross domestic product (GDP) has been projected to grow by 7.4 per cent in 2025-26, as per the first advance estimates (FAE) released by the National Statistical Office (NSO) today. Private final consumption expenditure (PFCE) is projected to drive the GDP growth in 2025-26 with a seven per cent expansion.

Goldman Sachs forecasts FY27 GDP growth at 6.8%

Goldman Sachs expects India's GDP growth in 2026-27 to moderate to 6.8 per cent from about 7.3 per cent in 2025-26. In a report, the brokerage projected real GDP growth of 6.7 per cent in calendar year 2026 and flagged firming inflation as a key constraint on further monetary easing. Retail inflation is estimated at around 3.9 per cent in 2026, close to the Reserve Bank of India's four per cent target.

53.2 million quintals of sugar produced in Maharashtra

As of 5 January 2026, mills in Maharashtra have crushed 60.2 million metric tonnes (MMT) of sugarcane. Around 53.2 million quintals of sugar have been produced. The average sugar recovery rate currently stands at 8.8 per cent. Of the 195 mills that are actively crushing, 97 belong to the cooperative sector and 98 are privately owned.

Seeds Bill 2025 likely to be presented in Budget session

The central government plans to introduce the Seeds Bill 2025 in the Parliament during the first phase of the Budget session in February 2026, according to Agriculture Secretary Devesh Chaturvedi. The Bill, which will replace the Seeds Act of 1966, proposes mandatory registration of seed varieties, dealers and producers to improve quality control and traceability, including QR codes on seed packets, while allowing farmers to save and exchange farm-saved seeds without registration.

RBI tightens RPT rules

The Reserve Bank of India (RBI) has tightened rules on related-party transactions (RPT) for banks and non-banking financial companies to reduce conflicts of interest and strengthen governance, according to media reports. The amendments will come into effect from 1 April 2026. The definition of related parties has been expanded to include promoters, directors, key managers, significant shareholders, their relatives and entities they influence.

Ministerial-level India-EU trade discussions held in Brussels

The Union Minister of Commerce and Industry undertook a two-day official visit to Brussels on 8-9 January 2026, reflecting intensified diplomatic and technical engagement toward concluding the India-EU Free Trade Agreement. Negotiations, re-launched in June 2022 after a prolonged hiatus, had completed 14 rounds and several ministerial interactions. Discussions with the European Union's Commissioner for Trade and Economic Security focused on providing strategic guidance, resolving outstanding issues, and expediting a balanced and ambitious agreement supporting labor-intensive sectors, MSMEs, farmers, and integration into global value chains.
